COURT ORDER
VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES
EFFECTIVE June 1, 2022

Pursuant to 479.050, RSMo, Supreme Court Rule 37.495, the undersigned Municipal Judge of the Village of Riverview does hereby order that the following designated offenses shall be payable to the Valley Park Municipal Court Violations Bureau. A person may pay specified amount of the fine and costs to the Bureau in person, by mail or through an electronic payment system before the court date and time for the initial court appearance. Said payment constitutes a guilty plea and waiver of trial.

This schedule is divided into two parts. Part I consists of the Municipal Court Uniform Traffic Violation Schedule, for moving violations (points). Part II consists of the Municipal Court Uniform Traffic Violation Schedule for non-moving violations.

Court Costs
In accordance with Missouri statutes and ordinances adopted by the City, **total Court Costs shall be \$29.50**. This includes the basic Court Costs of \$12.00, Crime Victim’s Compensation Surcharge of \$7.50, Law Enforcement Training Fund of \$2.00, Peace Officer’s Standard Training Fund of \$1.00, and an Automation Fee of \$7.00 for a total of \$29.50. **Court costs shall be paid in addition to the fine.**

- If your MOVING violation involved in an AUTO ACCIDENT, you must appear on your court date.
- If you were 17 years of age or younger and received a moving violation, you MUST appear on your court date. You must bring a parent or legal guardian with you to your court appearance.
- You may pay your violation by mail, in person during business hours
